The municipal elections in November will be swept by candidates of the newly-formed Prohibition Party. They will have campaigned on a platform of prohibiting everything.


In December, as the new year becomes the old one, the Leader will announce its list of New Year's resolutions. First among them will be a pledge to stop making predictions.

STATE BUDGET TRIPLES OVER LAST TEN YEARS

Typical of most governmental spending programs, New Jersey's state budget has suffered a steady increase over the past decade. This is indicated in the latest edition of "New Jersey Fiscal Facts," prepared annually by the New Jersey Taxpayers Association, a division of its parent public information publications.

Budgeted appropriations were cut by 10 percent in 1969, but increased by 10 percent in 1970 as compared with its \$87.4 million authorization ten years ago.
