Four Candidates File Petitions For School Bd.

Two Incumbents Drop From Race, Third Will Run

Contests in the February school election were assured here today with the announcement that four candidates already have announced their decision to seek the three vacancies. One of the three incumbents whose terms will expire has indicated he will ask reelection. Two others have revealed they will retire from the board.

Evidence of the increased interest being taken by women of the community is found in the announcement of two female residents that they are candidates. They are Mrs. Gretchen Forbes, of 160 South Springfield avenue and Mrs. A. Russell Hillier, of 22 Park lane. Mrs. Forbes, a member of the Springfield Women's Club, is the wife of Regional School Commissioner Raymond Forbes. She has been active in civic work here over a period of years.

Mrs. Hillier was a member of the School Advisory Committee. She and Mrs. Forbes both have been interested in school affairs for a number of years. Both of them played prominent parts in education the municipality as to the need for new schools here. They also, together with other women of the community, helped to get out a heavy vote in the referendum on the new school.

The third new candidate is Alan R. Cunningham, of 18 Clinton place. A resident of Springfield for the past six years, he is a supervisor in the technical service division of the Esso Standard Oil Company. He has two children, one of whom is in the first grade of the Raymond Chisholm School. Cunningham is a graduate of the Colorado School of Mines. He served four years in the Army Air Corps during the recent war, being separated with the rank of first lieutenant.

The fourth candidate, to date will be the lone incumbent who has indicated he will file. He is Commissioner Herbert O. Bailey, of 98 Henshaw avenue.

Declining to run for reelection are Wilbur S. Eno, former vice-president of the board, and Mrs. Janet Champlin, the first woman to be elected to the board.

Eno is a member of the technical staff of the Bell Telephone Laboratories at Murray Hill. He expressed belief it is time for other interested citizens to avail themselves of the opportunity to serve on the school board.

Mrs. Champlin said her primary purpose in serving as a board member had been to see that the new school was completed and the school playgrounds reconditioned.

Candidates must file nominating petitions by January 21. Intentions are that there may be additional filing before the deadline.

Regional Board Set for Election

Four members of the Regional Board of Education will be chosen at the annual election scheduled for Tuesday, February 3. The budget also will be voted on at that time in the six supporting municipalities of Springfield, Kenilworth, Berkeley Heights, Clark, Mountaintide and Garwood.

Decision by the board members on seeking reelection is expected to be made this evening at the monthly meeting. At least one new board member is assured as the result of the recent resignation of Richard N. Southgate of Berkeley Heights. Southgate, who is vice-president of the board, resigned effective February 1 so his successor may be selected to fill the remaining year of his term. He is retiring because of the pressure of private business, he reported.

Others whose terms end in February are Bertram J. Bertolami, of Garwood, the president; William Melick of this township; and Joseph M. Benintente, of Kenilworth.

Indications as the Sun went to press yesterday were that Commissioners Melick and Bertolami probably would seek another term on the board and that Commissioner Benintente probably will decline another three-year term. He recently indicated he was finding difficulty in finding time to devote to school board problems.

It was expected that the trio of members whose terms are expiring will make known their intentions this evening.

Firemen Fight Truck Blaze

Springfield and Millburn firemen were called out Friday noon to extinguish a blaze in a garbage truck at Morris and Millburn avenues. A traffic jam resulted with police rerouting traffic over Farley place for nearly half an hour.

Firemen laid several hose lines from hydrants to extinguish the blaze. Police said the truck's contents suddenly flared up. It was owned by Peter Roselle and Son of East Orange. Hot ashes may have touched off the flames, it was said.

Damage, according to police, was confined to the body of the truck. Detective Vincent Pankava and Patrolman Daniel Maddling and Louis Quinton were at the scene in addition to the firemen.

Accident Victims Receive \$30,000

A verdict of \$30,000 has been awarded by a jury in the court of County Judge Walter Hetfield to two New York men for damages suffered in an auto accident in Route 20 here on September 10, 1949.

Alvin Wolff, of New York, was awarded \$20,000 and Jack H. Stacy of Flushing, L. I., received an award of \$10,000. The defendants were David Greenberg, of Brooklyn, driver of one car, and Charles Melzer, of New York, the owner.

The plaintiffs charged the Melzer car went off the side of the highway and struck their parked vehicle. They received head and body injuries.

Joseph Weintraub of Newark was the plaintiff's attorney. George F. Lahey, of Newark, represented the defendants.

Union Official Here Fights Extradition by New York

Pasquale (Pat) Ferrone of 3 Shumpick road, will appear before Magistrate Harry Pine in Newark next Thursday for a hearing on the attempt of New York State to extradite him.

Ferrone was arrested in Newark Friday on a New York charge that he and another official in a longshoremen's union extorted \$45,000 from a broker before they would permit the unloading of a \$3,000,000 shipment of Russian furs at the Bayway Terminal docks in Elizabethport in 1950.

Ferrone was released in \$20,000 bail. He is business agent and secretary of Port Newark Local 1235, International Longshoremen's Association, which has jurisdiction over longshoremen working at the Bayway docks.

His indictment by a New York County Grand Jury stems from testimony given last week to the New York State Crime Commission by Gregory Butman, president of the British-American Fur Corporation.

Butman testified he had paid a total of \$70,000 to Ferrone and the late Anthony (Joe the Gent) Giannomasi, who was the local's

Police Recover Hold-up Sedan

Township police Sunday recovered a black taxi-cab taken in Summit in the holdup of a South Orange cabbie. The 1951 model vehicle had been abandoned in the parking lot in the rear of a Morris avenue tavern.

The cab was found only a few blocks from the scene of the robbery in Morris avenue, Summit. An unidentified man, who was the taxi's "fare" held up the cab driver and owner Peter Cogan, 57, of 122 Irvington avenue, South Orange, and took \$12 and the cab from him.

Police said the thief is about 35 years old, and weighs about 175 pounds. He grabbed Cogan by the neck and jabbed what may have been a revolver into him and asked for money. He took the cab despite Cogan's plea that it was his only means of making a living.

Mayor Will Name Recreation Group

Appointment of the new municipal recreation commission is expected next month. Following the appointment of five board members by the Mayor and selection of one each by the Board of Education and the Township Committee from their own membership, the commission then will be in a position to make decisions for the first time.

The ordinance establishing the commission was passed at a recent meeting of the governing board. It provides that the five members' original appointment will be staggered. Members must be residents of different election districts.

John M. Keith, former chairman of the recreation committee, who urged establishment of a recreation commission, said the ordinance generally is approved by members of the former recreation group. However, objections to a few technical provisions are being reserved, he pointed out.

Serving without compensation the commission will have the power to acquire land for playgrounds and other recreation areas. It will be able to hire supervisors and assistants and will schedule recreational activities. Funds will be provided in the township budget.

Police Recover Hold-up Sedan

Fate also played a part in the proceedings. Chief Thompson pointed out as the alleged hold-up man, Robert E. Sprull, 33 years, of 33 Prospect street, Newark, pointed his revolver and fired point blank at Ennis. The gun failed to go off.

Sprull was caught in the tavern, police said, after he had threatened a dozen customers by waving his revolver menacingly. The proprietor, Stanley Berke, ran upstairs to his apartment during the confusion, and telephoned police.

Detective Vincent Pankava, at headquarters, dispatched Ennis and Patrolman John Baber to the tavern. They were cruising near the Mountaintide line in a radio car. Ennis entered the tavern while Baber guarded a side entrance. Ennis, who has been a month, found the intruder dipping member of the police force only a his hands into the cash register, police said. When he attempted to arrest him, Sprull, a Newark Negro, who formerly lived here, tried to fire his gun and then fled to a darkened room in the rear. There he finally surrendered to the two patrolmen.

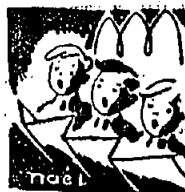

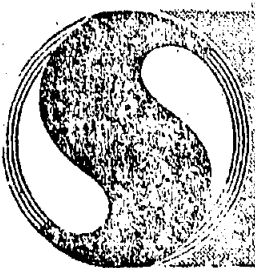
