Local Schools Watch Health Of Children

"Mrs. Jones, this is the school nurse. I would like very much to talk with you about your son, Bobby. The school doctor has just finished the physical examination in Bobby's grade and he suggested that I talk with you about Bobby's weight. Would it be convenient for me to call on you this afternoon?"

Each fall similar conversations are carried on in communities where a well-organized school health program is in effect. Springfield is such a community.

The school personnel is well aware that greater learning takes place when the child is physically healthy and well adjusted emotionally. To aid in securing this balance, the health program is aimed at early detection and correction of defects which might be a barrier to learning.

The first step in school health services is the pre-school sound-up. At this time a physical and dental examination is given by the school physician, Dr. Henry P. Dengler, and dentist, Dr. Murray Balaban, to detect, as far as possible, any deviation from the normal. Suggestions are made to the parents as to any correction that should be made prior to the entrance to school in the fall. At this time immunization is checked and school requirements are explained to the parent.

From the very day of the fall school opening, the health room is a bee-hive of activity. The height and weight of each student is taken several times a year and more frequently when closer supervision is needed.

Hearing and vision testing by use of methods designed especially for school use are made as soon as possible by the nurses, Miss Florence Gaudinier and Mrs. Lillian Hauffer. In many instances these tests have disclosed defects which were proven to be a basis for poor scholastic achievement.

The school physician and dentist play an important part in the work of the health room. Their work continues throughout the year—not only for the basic examinations but also in an advisory capacity in maintaining the most healthful school environment. Their services are available for

Lack of Proper Support May Curtail PTA Program

"We're pinching nickels until they holler, and we're willing to go on doing that, but please give us the nickels to pinch," said Mrs. L. E. Skousen, President, to the few members of the Parent-Teacher Association who showed up for last Monday night's meeting at Gaudinier school.

To these members, present, 50 per cent of whom were teachers, she tried to picture the financial status of the organization. For the first time in the history of the Springfield Parent-Teacher Association, because of the lack of participation of the majority of parents, in an endeavor to make this a really successful organization this year, it may be necessary to curtail several services provided for the children that have been financed by the group.

These include the health service fund and either the 8th grade class party or the scholarship awards, budget items, or the film library and the music fund, extra projects furnished by the PTA. Mrs. Skousen, in her brief talk, pointed out that it would take only 54 cents per member in addition to the regular membership dues, to more than meet the budget of this year.

She said that the cake sale which was labeled a success, was in reality for a large group such as

this not a success, since only a small number of the members cooperated. Of the 300 pieces of baked goods requested of the parents, only about 260 were received and, if the full amount had been forthcoming, they could not have been sold because the 165 25 cakes were practically given away.

Mrs. Henry Reichard, Chairman of the Children's Theatre, too, pointed out the lack of cooperation on the part of PTA members and parents in making this a success, and stressed again the possibility of the need to cancel the last play of the series.

Unless almost 350 admission tickets are sold for the next production, "Kit Carson," the PTA will have to abandon the project and suffer a loss on the refund of money on purchased season tickets. Since this is as has been so often stressed a non-profit project and all monies are used to offset any expenses involved.

Why the majority of the Parents in Springfield are willing to sit back and let the few who are willing to do the work of the executive board meetings this year. In an effort to get the general opinion of the regular members of the organization, Mrs. Skousen instituted a suggestion box, so that members could give constructive criticism of the programs and activities of the organization and still remain anonymous. To date no such suggestions have been forthcoming.

Prior to Mrs. Skousen's announcement Rev. Bruce Evans, pastor of the Springfield Presbyterian church gave the invocation and Mrs. Ruth Osborne led the singing to the flag and the singing (Continued on page 6)

Voters OK New Regional High School

Voters in the Union County Regional High School district approved overwhelmingly an expenditure of \$1,650,000 for land and a new high school in Clark and land in Berkeley as a future school site in the special election held on Monday.

Plans call for a \$1,825,000, two-story, 34-classroom building and acquisition of a 25-acre tract in Westfield avenue, Clark Township, as the school site and 42 acres in Berkeley Heights for future expansion for a total of \$1,250,000. The expansion program was approved in all but one of the six sending communities. In Kenilworth, where the strongest opposition had been voted, the turnout at the polls was surprisingly small. The proposal was rejected there, 298 to 23.

The closest vote was in Garwood, where the proposal was carried, 189 to 118. John L. Banyasz, one of Garwood's two representatives on the school board, was the lone board member who objected to the inclusion of the Berkeley Heights land purchase in the ballot question.

In the remaining towns the proposal was supported by large margins. The balloting was: Clark Township, 1,990 to 35; Berkeley Heights, 524 to 19; Mountainside, 335 to 46; and Springfield, 274 to 58.

The board thanked voters for their support and issued a statement which said, in part: "The results of the election clearly indicate the overwhelming approval by voters in the Regional High School district of the expansion program. It is now possible to continue to provide adequate high school facilities for the children of all the Regional communities."

The new school, which is slated for September, 1955, occupancy, will have a capacity of 600 students and service Clark and Garwood. Plans include an auditorium, cafeteria, gymnasium, library, five outdoor play areas and administrative guidance and health office units. Fred A. Elsas, of Union is the architect.

Township Committee Act on Re-zoning Haselmann Site

Action on the application to rezone what is known as the Haselmann property on South Springfield avenue, near Route 22, will be taken at regular meeting of the Township Committee next Wednesday but no one is ready to forecast what the town fathers will do.

Owners of the property are said to have several industrial firms ready to purchase a good portion of this site but the Township Committee and Planning Board are believed to favor one-family houses in this area.

This matter has been the subject of a rather bitter controversy between the property owners and the zoning authorities but a settlement has evidently been made and a decision is to be handed down at the next meeting.

Springfield citizens point out that there are many sites still available along Route 22 and that there is no real need for rezoning any section now set aside for homes.

License Revoked; Pays Fine of \$103

A Jersey City autoist, who works in Morris Plains was fined \$103 by Magistrate Henry C. McMillen in the Springfield Municipal Court Monday night for driving his car while his name was on the revoked list.

Springfield Residents Want Railroad Whistles Muffled

Residents in Springfield—those living near the Rahway Valley Railroad tracks—want something done to compel the railroad to cut down some of the shrill whistling of the locomotive and the unnecessary noises late at night.

Last Wednesday night, according to residents along Baltusrol Way, Tucker, Henshaw and Hawthorn avenues, the locomotive, hauling a load of cars, let loose a series of shrieking blasts that woke up all those already asleep, and startled those still awake.

"Something should be done about blowing such loud-shrieking whistles as late as 11 o'clock at night," said one father of two children awakened by the blasts. "The railroad doesn't have a regular schedule and we are still wondering what was so important and urgent about that particular delivery of material to make a trip necessary after 11 o'clock at night.
