

Candidates Confident As Local Race Nears End

Bonadies Seen As Sure Victor, Say His Experts

Enthusiastic endorsement, coming from all groups and all sections, for Vincent J. Bonadies, candidate for the single vacancy on the Township Committee at next Tuesday's election, is "snowballing" throughout Springfield, and the political prophets who understand the signs and have made a study of local campaigns, forecast an overwhelming victory for Bonadies.

"Vince Bonadies will win next Tuesday," said one of his energetic volunteer workers, "because the taxpayers know he is capable, that he has presented a very forward looking program, and that the present members of the Township Committee will be able to strike a harmonious note in working with him—while Marshall's presence on the governing body would stonewall every wheel in the operation of our Township affairs. Three members of the present Township Committee have made public announcements that they couldn't consider working with Marshall.

"Voters will hop over party lines," this same Bonadies backer stated, "and the list of workers for Bonadies include leaders of all local groups. 
Keane Issues Statement; Is For Bonadies

Deserves Victory On His Record, Says Marshall

Robert W. Marshall, former mayor of Springfield and a member of the Township Committee for six years, makes a final appeal today for the support of the voters in his campaign to regain his seat on the governing body in next Tuesday's general election.

"Bob," as he is affectionately known to all since he returned from the service and was induced to enter local politics, points with considerable pride to his service to Springfield during the six years of his membership on the governing body and hopes the voters of Springfield "will consider seriously the facts and issues in this campaign and vote for an accepted record, not a handful of empty promises."

Marshall's friends and supporters carried him through a very bitter campaign in the Republican primary, and the former mayor was victorious despite the fact that he was compelled to build up his own organization. "Bob was so occupied with his duties as Mayor," one of his workers said yesterday, "that he didn't devote the time necessary when his six years of service to Springfield was interrupted—but he permitted us to enter his name in this year's primary and the result is now history."

Marshall held a long afternoon conference with Republican Municipal Chairman Charles F. Beardsley, and other responsible Republican leaders yesterday and discussed the kind of a campaign to be waged in the final stages of the current campaign. It was decided to have Marshall talk to the voters through the medium of a statement, asking all Springfield citizens to carefully weigh the facts as presented by both candidates and then cast a ballot next Tuesday for the man who can best represent them on the governing body, who they insist is Marshall.

Workers for the Marshall cause are active in every district of Springfield and those who have watched him in action while Mayor and a member of the Township Committee freely admit that he has always had the best interests of Springfield at heart and his six year job deserves the support of the eligible voters. Bob has been doing some old-fashioned electioneering, shaking hands with old friends, greeting newcomers to Springfield and readily discussing with all those interested any of the problems now confronting the growing municipality.

Marshall will have headquarters in one of the stores of the new Lyon's Arcade Building off Center street from which the campaign volunteers and supporters will work in his behalf while the polls are open on Tuesday.

Former Mayor Marshall Makes Final Appeal To All Voters

Following is the statement issued today, by former Mayor Robert W. Marshall appealing to the voters to elect him on Tuesday, November 2, to the vacancy on the Township Committee:

"I am making my final appeal to the voters of our Township urging them to vote for a record, not a promise. I have served six years on the governing body and am familiar with every phase of the entire Township every phase of government.

"Experience—actual work on the job is important and my record, my leadership and my judgment in matters of great importance to the welfare of Springfield has never been challenged. I can point with considerable pride to the fact that people who have called on me for service as a Township official, are now stepping forward and being counted as my supporters in this campaign. Springfield voters are asked to avoid congestion and inconvenience at next Tuesday's general election by going to the polls early which will be open from 7 a. m. to 8 p. m. Eastern Standard Time at the following:

- District No. 1—At Morris Avenue Motor Co., 155 Morris Avenue.
- District No. 2—Gymnasium, James Caldwell School, Mountain Avenue.
- District No. 3—Gymnasium, Florence Gaudineer School, South Springfield Avenue.
- District No. 4—American Legion Building, Center Street.
- District No. 5—Gymnasium, James Caldwell School, Mountain Avenue.
- District No. 6—Gymnasium, Raymond Chisholm School, South Springfield Avenue and Shunpike Road.

To those who are using the voting machine for the first time, it is again pointed out that NO ONE KNOWS HOW YOU'RE VOTING—IT'S A SECRET BALLOT—and you can hop from the Republican column to the Democratic line—and vote for any individual you select no matter which party he represents. You DO NOT have to vote all Democratic—or all Republican if you once start in that line. **SELECT THE MEN YOU WANT.** Pull the lever down over their names—LEAVE THEM DOWN—and your vote is recorded as you move the red handle of the curtain to the left as far as it will go. Bonadies' emphasis on an industrial commission to relieve the heavy burden of the taxpayer is a very important item in his campaign for election. (Continued from page 1) disassociate himself from this organization. On the contrary, he is still its registered agent and is permitting his law office to be used as the principal office of the organization.

This so-called Pro-Constitution Association has so far devoted its efforts to promoting the Bricker Amendment, whose passage would have severely crippled the President's constitutional authority to conduct foreign policy. President Eisenhower has taken the strongest stand of his two years in the White House in opposition to the Bricker Amendment. Now it appears that Mr. Shepard, who would have the voters of Union County believe that he is going to support the President, is one of the prime movers in the campaign to secure passage of the Bricker Amendment in the teeth of the President's militant opposition.

In two months of campaigning, the only argument that Mr. Shepard's supporters have been able to muster on his behalf is that he is a Republican. However, Mr. Shepard received only 22 per cent of the votes cast in the Republican primary, and represents only the extreme right wing of his Party. His whole record is one of consistent opposition to the progressive Republicanism represented by Eisenhower and Case.

Despite the magnificent job being done by our Recreation Commission with limited funds, teen-agers lack proper facilities for recreation or community activities. Hence for the average family unit in Springfield of 3.5 persons it costs the town \$49.00 to provide services for each residential unit. Since the average residential unit pays about \$20.00 in taxes the burden must be shared by industry requiring fewer services and providing higher taxable values.
We must realize the welfare of people to encourage this industrial development but we must be always mindful to keep faith with the people and provide the maximum zoning protection of residential property.

ORDINANCE
AN ORDINANCE REGULATING THE DISPENSING OF FOOD OR BEVERAGES FROM MECHANICAL VENDING DEVICES AND FIXING PENALTIES FOR THE VIOLATION THEREOF.
BE IT ORDAINED by the Township Committee of the Township of Springfield, in the County of Union, as follows:
Sec. 1. It is hereby determined that dispensing or sale of food or beverages from mechanical vending devices is inimical to the health, welfare and safety of the residents of the Township unless said mechanical vending devices are located within the confines of a building or a structure, the principal use of which is not dedicated to the sale or dispensing of food or beverages from mechanical vending devices when at least 90% of the floor area of said building or structure is devoted to such purposes other than the sale or dispensing of food or beverages from said mechanical vending devices.
Sec. 2. It shall be unlawful on or after the effective date of this ordinance for any person to operate, maintain, use or dispense any mechanical device for the sale or dispensing of food or beverages in any location other than those set forth in Section 1 hereof.
Sec. 3. Any person, firm, association or corporation violating any provision of this ordinance shall, upon conviction, be punished by a fine of not more than \$200.00 or 90 days in jail, or both, upon the discretion of the Court.
This ordinance shall take effect immediately upon publication after final passage in the manner provided by law.

During the last few weeks "Your Librarian" has been pondering the subject of magazines. The Springfield Public Library renews most of its subscriptions every two years. Next year, 1955, is the year they most come due. The question is: "If we are to get magazines that most of the people want and many people need, how much money should we request from the Township Committee?"

Our thinking has been revolving around this idea. Although we now subscribe to a number of good magazines, we naturally get requests for some that we do not have. These are usually for the more expensive titles: Fortune, Vogue, Holiday, House Beautiful, etc.

Then we must think of the young people. They need Science News Letter, Current History, Scientific Monthly, and the news periodicals for school work. Back numbers of these are among the most valued holdings in the library. Now that we have an index beginning with the year 1950 in the Readers Guide, the back numbers are even more useful. This index covers more than fifty periodicals.

According to the requests received, about the most popular title is Consumers' Research Bulletin. Should we add Consumers' Reports?

Although there are many angles to the whole question let us consider just one more. We subscribe to Musical America, but in the past have done nothing with art magazines. Yet we have so many calls for art books that we know there are many people interested in art in Springfield. Should we not get them something?

For the public's convenience, we are keeping a list of the magazines being considered at the main desk in the library. Anyone who wishes may drop in to look it over. We would like to benefit by the advice of various people. Those not able to come to the library can send opinions on postal cards.

It seems likely that a great many readers do not know that back numbers of periodicals may be borrowed. The current issues are kept in the library to represent the subscription and also for those who wish to read them there. But as the new magazines come in, the old ones may go out for home reading.

Now is the time for the Springfield readers to let the librarians know what they want for the coming year: The Springfield Public Library is here to serve you.
